Introduction to the Alliant 2 Small Business GWAC

GSA's Alliant 2 Small Business (A2SB) will be a multiple-award, indefinite-delivery, indefinite-quantity (IDIQ) Government-wide Acquisition Contract (GWAC) offering comprehensive and flexible IT solutions worldwide. A2SB will provide best-value information technology (IT) solutions to federal agencies, while strengthening opportunities in federal contracting for small businesses.

The scope of A2SB is aligned with the Federal Enterprise Architecture, which encompasses all components of an integrated IT solution, including new technologies that may emerge during the life cycle of the contract. This GWAC will provide IT solutions through performance of a broad range of services, which may include the integration of various technologies critical to the services being acquired.

No protests on orders \$10 million and under, except on the grounds that the order increases the scope, period of performance, or maximum value of the GWAC	Minimizes protest risk and supports timely order award for optimal mission support

Ordering

Prior to issuing orders under Alliant 2 Small Business, federal contracting officers (COs) must receive training on the use of the contract and be granted a written delegation of procurement authority from the GWAC program office.
